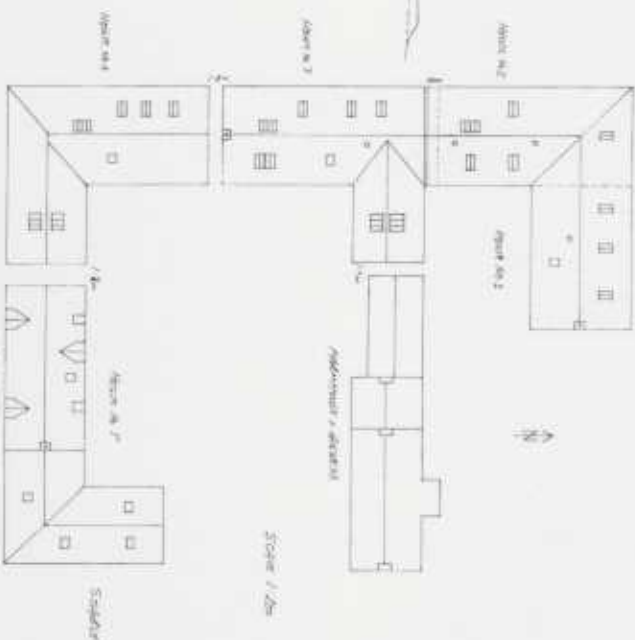
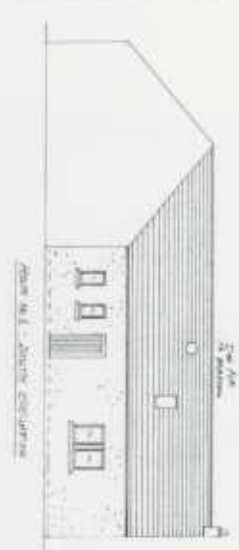
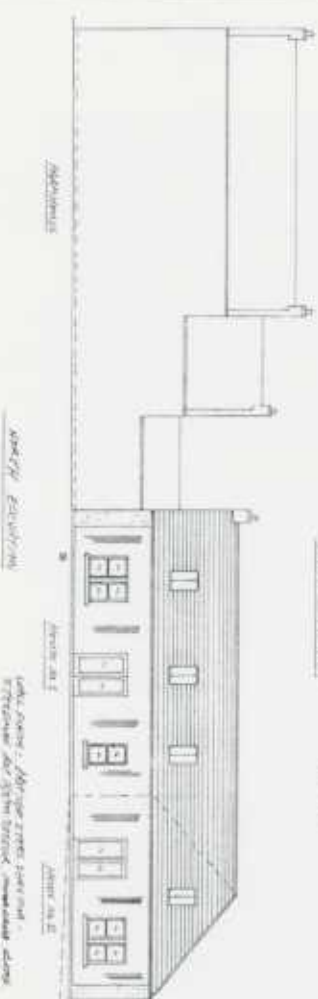
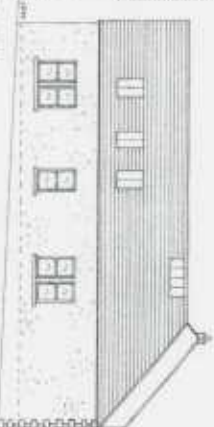
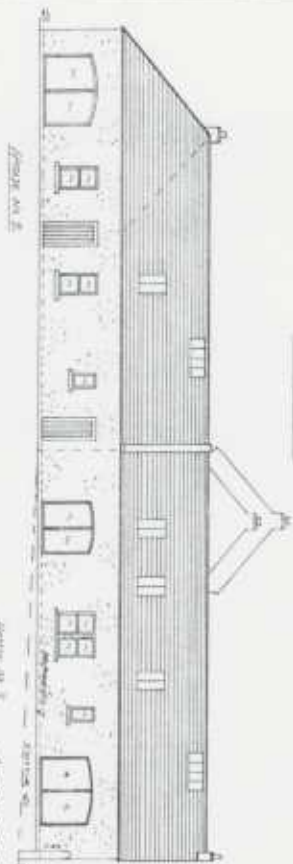
Architectural section drawing showing a cross-section of the building with a gabled roof.

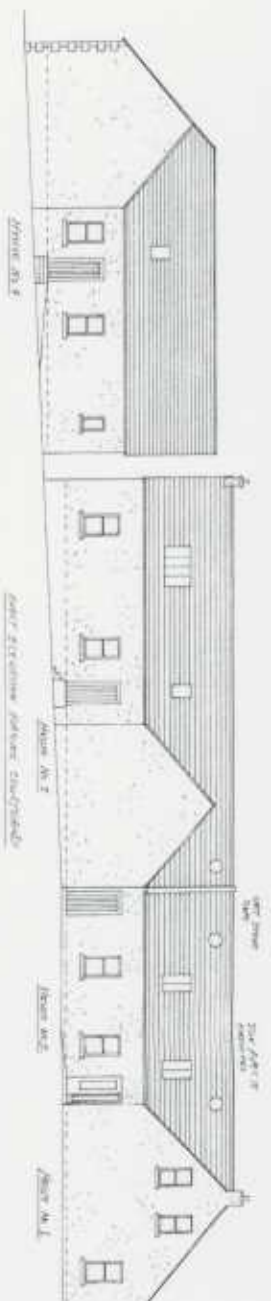
