

Mo-Ranch by the numbers

- 1949—Presbyterian Mo-Ranch Assembly established as a conference center in the Texas Hill Country, for the Synod of Texas, Presbyterian Church (U.S.)
- Mo-Ranch derives its name from a previous owner, oilman Dan Moran
- Mo-Ranch has a covenant relationship with the Synod of the Sun of the Presbyterian Church (U.S.A.), which includes Texas, Oklahoma, Louisiana and Arkansas
- A 33-member Board of Trustees oversees the conference center, Day-to-day operation is directed by a president/CEO appointed by the board
- 90 permanent and 60 summer employees make up the Mo-Ranch staff
- 28% of Mo-Ranch's operating costs comes from donations and gains from endowment investments held at the Texas Presbyterian Foundation
- 45,000 men, women, and children enjoy Mo-Ranch annually
- 2,400 people enjoy about 20 Mo-Ranch-sponsored events annually
- 544 boys and girls benefit annually from Mo-Ranch's Summer Camps program
- 3,000 people of all ages, but primarily school groups, annually participate in the Mo-Ranch Environmental Leadership Program
