I wish to apply to the **Wanganui Jockey Club** Racing Club for approval to train and use the training facilities of the Club for the purpose of training thoroughbreds. I understand and acknowledge that should permission be granted for me to use the Club's facilities it will be subject to my complying at all times with the following conditions:

- 1) I hold a current Trainer/Owner Trainers Licence, issued by NZTR
- I agree to abide by the Rules of Racing, the Track regulations and any directions or instructions issued by the any Stewards Racecourse Manager and/or Club official, at all times.
- 3) I acknowledge that any horse, which utilises the Club's facilities, must have a current stable return lodged, showing **Wanganui Jockey Club** as the training venue, unless otherwise approved. I acknowledge that unless my licence fees are paid promptly and on time approval to train on course will be withdrawn by the Club.
- 4) I will inform the Club in writing of the number of horses I have in work.

Track rules

The Wanganui Jockey Club requires trainers and staff to adhere to the following rules at all times when using the stable and track facilities at the Wanganui racecourse.

Rental charges

(all prices are GST inclusive and current as at 4 April 2016)

General conditions

- 1. All thoroughbred horses worked at the racecourse facilities must be officially licensed with the governing body under a trainer with an appropriate training license.
- 2. Trackwork should be conducted between the hours of 6am 9am when the gap will be officially manned. Training outside these hours is the responsibility of the user and must have the prior permission of the Track Manager.
- 3. No jumping before 8.30am without prior permission from the Track Manager.
- 4. Boxes, feedrooms and surrounding areas are to be kept clean and tidy at all times.
- 5. Any damage to boxes or yards must be reported immediately to track staff and may be the responsibility of the tenants.
- 6. Yards are required to be kept clean, raked and leveled with dung removed at all times.
- 7. No horses to be let loose on any area of the Racecourse.
- 8. All horses to pick on areas allocated by Racecourse staff.
- 9. All boxes, feedrooms and yards are to be vacated prior to Race meetings if requested to do so, other than those horses racing on the day concerned. When boxes are vacated they must be left clean and ready for use at the race meeting.
- 10. The TRACK FEES folder must be completed accurately daily showing full details of:
 - a. Name of horse
 - b. Owners name and phone number (for all new owners)
 - c. Number of days used for Track
 - d. Number of days that boxes & yards used
- 11. Only use the designated boxes allocated by the Course Manager.
- 12. No feed bins are to be removed from boxes and used in the yards.
- 13. No unbroken horses to be accommodated on Course.
- 14. No alcohol to be consumed or stored in the stable area.

15. No smoking in the stables or stable area.

All accounts are due and payable by the 20th of the following month. Interest will be charged at 2.5% on overdue accounts. The Wanganui Jockey Club reserves the right to deny persons access to use the Racecourse facilities with overdue accounts and also demand payment in full up front from any person wishing to use the facilities that has been a previous debtor.

Failure to pay overdue accounts within 3 months may result in Trespass notices being used and commencement of debt recovery and collection activity.

Declaration

I acknowledge that I have read and fully understand the conditions on which approval may be granted by the Club to train and use the facilities at the racecourse. I further acknowledge that should I fail, at any time during the course of my use of the facilities, to adhere to any of the above conditions, such failure may result in the Club, at the Club's sole discretion, withdrawing permission to use the facilities on course without further notice. I acknowledge that should my permission to use the course or facilities be withdrawn, I will immediately cease to use the same.

I also acknowledge that I have received and read the 'Track Regulations and Policies Relating to Trainers & Track Riders Approved to Train on the Wanganui Jockey Club Racecourse' document and understand the contents therein and agree to comply with such policies.
